For revenues, we have over 979K from Alberta Education. Our actual enrollment is 3% lower than the budgeted. Alberta infrastructure received over 26k, and Other fees and Transportation received over 85K. Total revenue of May 2024 is over 1.1M.

For expenses, Instruction K-11 is over 824K. Operation and maintenance expenses are over 211K. Transportation expense is over 152K. Board and system is over 40K. Total expense is over 1.2M. May deficit is 61K.
