a. School Year Update

Secondary School Facility:

- We have collaborated with ACI Architecture to develop a schedule for our secondary school facility.
- A meeting with Capital Planning is scheduled for Tuesday, November 21, 2023.
- Unfortunately, we are experiencing issues with boiler floods that require immediate attention. We are actively addressing this concern and will keep you informed of the progress.

Professional Development:

• Our focus on Professional Development includes sessions on Social-Emotional Learning and School Culture.

School Culture:

• There is positive collaboration between primary and secondary schools, fostering

a sense of unity and shared purpose.

Partnerships:

- Significant developments in partnerships include secondary school students actively contributing to primary events.
- Collaboration with PYPE police to enhance partnerships with multicultural youth.
- A successful November presentation on cyberbullying and careers in forensics.
- Exploration of a joint research project with EPS about student perceptions of police, involving an anonymous survey.
- Securing a \$50,000 grant from NAIT Dual Credit to offer courses in Human Anatomy and Medical Terminology, creating a unique Pre-Med pathway.
- Plans for additional pathways in IT and business for the 2024-2025 academic year.

In addition to the above, here are some noteworthy highlights: Parent Outreach:

- Successful events included the Honor Roll Assembly and a family supper with a guest speaker on study and organizational skills.
- Ongoing planning for the Casino in spring and the Science Fair scheduled for Feb 15.

Academic Enrichment:

- Commencement of career counselling sessions and individual meetings to review credits and university entrance requirements.
